

Tender Notice for the Supply and Delivery of Computers/LCD Projectors/ Printers

Fully completed, duly signed by authorized signatory and sealed tenders along with the bid security not less than 2.5% of bid amount must be submitted to the following address not later than 12:00 hours Nepalese time on 31st day from the first date of publication of this notice. Tender documents received after that time will not be accepted. Telegraphic transfers will not be entertained.

7. Tenders will be opened in public at 14:00 P.M. on 31st day from the first date of publication of this notice in the presence of those bidders or of their authorized representatives, who wish to be present and the bid price will be read and recorded.
8. In case, the last day of issue and submission of tender document be declared a Bank holiday, tender document will be issued and submitted the next working day during office hours as mentioned above respectively.
9. Bidders may bid above mentioned any category of goods separately or in combination of them.
