The estimated amount for the works is ***Rs.3,263,636.86 (Three Million Two Hundred Sixty Three Thousand Six Hundred Thirty Six and 86/100.)Inclusive Vat and 0.45 % Insurance.***

Eligible Bidders may obtain further information and visit at the office of ***Agricultural Development Bank Ltd, Physical Assets Management Department, Ramshahpath, Kathmandu*** or may visit PPMO website www.bolpatra.gov.np/egg. Eligible Bidders have only option to submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egg. Bidders, submitting their bid electronically, should deposit the cost upon payment of a non-refundable fee of ***Rs.5,000.00 (In words: Five thousand only.)*** for bidding document in the project's bank account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

Electronic bids must be submitted to the office ***Agricultural Development Bank Ltd, Physical Assets Management Department, Ramshahpath, Kathmandu*** through PPMO website www.bolpatra.gov.np/egg on or before ***12.00 Hrs. on 11 December, 2022 (2079/08/25)*** Bids received after this deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at ***14.00 Hrs on 11 December, 2022 (2079/08/25)*** at the office of ***Agricultural Development Bank Ltd, Physical Assets Management Department, Ramshahpath, Kathmandu***. Bids must be valid for a period of ***90 days*** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of ***Rs.90,000.00 (In words:Ninety thousand only.)*** from Commercial Bank or Financial Institution except Agricultural Development Bank (If the bidder wishes to submit the Cash Security, the cash should be deposited in the above mentioned account), which shall be valid for 30 days beyond the validity period of the bid (i.e. ***120 Days***).
5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
6. The Purchaser reserves the right to amend or correct and accept or reject, wholly or partly, any or all the bids without assigning any reasons, whatsoever.
